From Pacific Counselling & Social Services to EMPOWER PACIFIC

Pacific Counselling & Social Services is currently going through a period of growth and development as we transition to a sustainable, transparent and multifaceted NGO. In order to facilitate a smooth change of public image, a two-day workshop was conducted for staff at our Head Office in Lautoka.

The workshop looked at enhancing the communication strategy of Empower Pacific to change our image of that as predominantly a counseling service provider- to an organisation that is a significant contributor to health and wellbeing targets established by the Ministry of Health and other key stakeholders.

Ms. Nicole Gooch, a Communications Officer at the Secretariat of the Pacific Community (SPC), facilitated the workshop and highlighting the importance of staff to reflect on where we have been as an organisation to where we are heading.

During the workshop, staff began to explore the link between the services we provide as an organisation, to that of government policies, regional development agendas, as well as to the Millennium Development Goals (MDGs). This was an important aspect of the workshop as staff began to shift their focus from their daily roles to their contributions towards big picture outcomes.

One such example is EMPOWER PACIFIC's HIV

VCCT Program delivered in partnership with the Ministry of Health. This holistic program contributes to Government's effort to meet goal number 6 of the MDG's that is, combating HIV/AIDS, Malaria & other diseases, as well as MDG's aimed at promoting child and maternal health, and reducing gender inequal-

The workshop also helped staff to acknowledge their collective effort to the Health Sector, Prison and the Social Welfare Department at the same time recognizing their role as a regional organization. One of the activities during the workshop included staff having to name stakeholders and rate their importance to the organization in terms of relationship. As a result, the staff were able to identify the need to build and strengthen relationships with other regional stakeholders and community groups. This was an important aspect as communication is a vital part of strategic developments, in which EMPOWER PACIFIC seeks to facilitate a more effective partnership to support government agencies and other NGOs to achieve the MDGs.

The workshop ended with the planning of the EMPOWER PACIFIC Launch program due to be held at the end of this month.

Small Business Training in Suva

The Income Generation Program (IGP) recently conducted business skills training in Suva. The training was held on the 18th of July at the National Diabetes Centre Training room and it was conducted by our Suva based Income Generation Program Officer, Koroka.

The participants consisted of 16 IGP clients who are aspiring entrepreneurs. These participants were referred from various programs within EMPOWER PACIFIC, in addition to referrals from the Salvation Army.

The purpose of the training was to empower clients and provide them information and on the

basics of business skills and management. One of the key objectives of the training was to provide participants an opportunity to draw up their own business plans, in addition to equipping them with the necessary skills to run their own business.

According to Koroka, who conducted the training, participants found the sessions very informative and in their evaluation, they reflected that it was something new, it was very encour-

aging and inspiring.

As a result it has motivated many to go back and start their own business.

EMPOWER PACIFIC will provide these participants a business loan to kick-start their business and continue to follow up with them regarding the long-term sustainability of their business, as they (participants) make their loan-repayments back to the organisation.

Sexualities, Sexual Rights and HIV in PNG and the Pacific Symposium Feedback

For three intensive days from July 11 -13, a congregation of fifty-three scholars, activists, policy-makers, and practitioners met at ANU, Canberra, Australia to exchange perspectives and engage in discussion on *Sexualities, Sexual Rights and HIV in Papua New Guinea and the Pacific.*

This workshop symposium was jointly convened by Professor Gilbert Hertz and Dr Katherine Lepani abd received support from the ANU Research School of Asia and the Pacific (RSAP), the AusAID International Seminar Support Scheme (ISSS), and the United Nations Development Programme Pacific Centre in Suva, Fiji.

Participants at the workshop symposium came from Papua New Guinea, Fiji, Solomons, Vanuatu, the Cook Islands, Nauru, New Zealand, France, Canada and Australia and consisted of Government representatives, academics, faith-based organsations, advocacy groups, and NGOs- including two of our own Empower Pacific team members.

For our EMPOWER PACIFIC staff, Vero & Lani, the experience was both challenging and eyeopening. Whilst the overall experience brought some key learning points, it also highlighted the need for research initiatives to be strengthened, encouraged and cultivated within the Pacific Islands.

Some key messages which the team took away from the symposium included;

• Patterns of stigma, discrimination and violence against women, sexual minorities and people living with HIV in the Pacific; • The persistence of punitive laws, many dating from the colonial period criminalizing sodomy and sex work and the urgent need for law reform

• The prominent role of Christian churches in both the prevention and treatment of HIV and the increasing conjunction of biomedical and faith-based healing.

• The crucial advocacy role of organizations representing women and sexual minorities and people living with HIV in defending human rights.

The Symposium has enabled the staff to bring back some valuable knowledge as well as constructive feedbacks that can be positively directed towards the professional development of EMPOWER PA-CIFIC's Research Department as a whole.

Health in Prisoners Research (HIP) Fiji update

EMPOWER PACIFIC in partnership with Burnet Institute has been intensively involved in a longitudinal (2011-2013) study of Health in prisoners (HIP). The research explores patterns of health, including HIV and sexual health, as well as risk taking behaviours amongst prisoners as the prepare to leave prison and return back into the community.

So far, HIP Research Officers have been involved in prerelease and post release interviews of prisoners and ex-prisoners at the prerelease stage, as well as I month and 4 months after release from prison.

One of the HIP Research Officers, Semisi Siga, recently paid a visit to Waimakutu village in the Namosi highlands to conduct a 4 month post- release interview. Upon his visit, he stated that it was a great opportunity to realistically experience how participants live and interact with their community members.

The family and community of this particular participant was receptive and provided their full support to the research, as well as to the information given by the Research Officer (as he was able to provide information on HIV & STI to the community).

With the aim to recruit 200 participants for this research project, so far, HIP Fiji has recruited a total number of 113 - pre-release participants, 62 - 1 month post-release participants, and 10 - 4 months post release participants. The preliminary results will be presented at the upcoming Pacific Islands Health Research Symposium to be held in Nadi.

Gender Based Violence Statistics Update

General Based Violence (GBV) as declared by UN definitions, refers to any physical, sexual and psychological violence occurring in the family, including battering, sexual abuse, rape within marriage, dowryrelated violence and violence related to exploitation of women or children within the household. GBV also refers to any physical, sexual and psychological violence occurring within the general community, including rape, sexual abuse, sexual harassment and intimidation at work, in educational institutions and elsewhere, trafficking in women and forced prostitution; and physical, sexual and psychological violence perpetrated or condoned by the state, wherever it occurs.

For EMPOWER PACIFIC, we have been working with a variety of GBV cases involving those perpetrated by a man against a woman, sexual assault, sexual abuse and cases of violence/abuse against any person because of their gender – including people who identify as transgender. These clients have been captured from Hospital wards, the Department of Social Welfare, referrals from community welfare organisatons, as well as self referral.

Another key way in which GBV cases are identified and referred to Empower Pacific is through screening administered questions during HIV pre/post test counseling at Anti-Natal Clinics in which our staff operate. Between the periods of March to June 2012, PCSS/EMPOWER PACIFIC facilitated a total of 3716 pre-tested clients at antenatal clinics across Fiji. Of these clients, 302 identified as being exposed to gender based violence or being afraid of their partner.

Furthermore, 180 expectant mothers reported to having experienced physical violence in the past 6 months. 208 mums out of the 3716 seen during pre-test sessions were referred for Counselling. In light of these statistics EM-POWER PACIFIC hopes to work in collaboration with government departments and other key stakeholders to address issues of gender based violence and uphold our commitment to MDGs aimed at reducing gender inequality.

Once referred to us, our goal is to provide continued support and encourage clients to take steps to ensure their safety, and that of their unborn child. Empower Pacific supports these mothers by offering counseling as well as social work services and referrals to other agencies, as appropriate. Some of the clients seen have reported back that through our services, they have been made aware of the Domestic Violence Restraining Order and other laws relating to Violence, including their rights to feel safe and the rights of their child to be protected from harm. For many, these fundamental rights were something they hadn't been aware of.

It is reasons such as these that EMPOWER PACIFIC's Social Work and counseling interventions in any GBV case are very much valued. Well done to the combined efforts of the whole Empower Team for facilitating effective referrals and contributing to the enhanced well being of many survivors of GBV.
