# **Chaplains Participate in Lowcounty**

During April, Chaplains Coleman, Cooper, Dewey, and Wojtkowski participated with various Lowcountry agencies in reenactments of DUI scenes. Several of these exercises are done in the spring for high schools as they approach prom to encourage students not to drink and drive. Chaplain Cooper stated, "It was inspiring to watch so many caring adults working so competently to make their point: to see what heartbreak drinking and driving can bring. I could tell by the students' comments as they left that they knew two things: they are loved enough for authorities to go to great trouble and expense to warn them and two, the warning is truthful and needed."

- 1. Chaplain Dewey met with members of the St. John's Fire District before the reenactments started. Chaplain Dewey had to leave early to go to an actual car fatality just moments later. As he says, "we're never bored!"
- 2. Chaplain Coleman stands by while EMS take the victim's body away from the scene. MeduCare provided a helicopter to fly the victim away from the scene!

In March, the Chaplaincy held the Pastoral Crisis Intervention course. It was attended by over 30 students which was taught by Chaplain Dewey. The course addresses how

to assist individuals or communities during a time of crisis, and it examines the impact that crisis situations have upon people, whether it is a psychological and/or spiritual impact. Nancy Egleston, who is on our Survivor Follow-up team stated, "The Pastoral Crisis Intervention class gave me a solid foundation and the basic tools I can use to offer support and help people find guidance as they process their loss."
