## **Directors Report:**

First football game (home) is Aug. 24 against Goshen. Tag Day (band only fundraiser) is set for Aug. 25 from 9 – 4. A used prop (large tarp is being purchased by the band in the shape of a pyramid) It will be rolled out on the field for the show – Mr. Stevens has offered a carpet roll to help with placement and removal for the show. Mr. Roemer also asked if someone would be willing to drive a separate trailer to away games and competitions to help transport the large number of pit instruments and the tarp. A motion was made to pay Tammy \$230.00 (in two separate checks) by Karen Shanks, seconded by Tim Stevens – motion passed. Tailgate Party – No report except that Diann will not be able to be there, so Gary Baldwin will step into her place and work with Jennifer Dougherty.

Quad Raffle – Mary Ann Henninger reported that tickets are currently on sale (\$10 each / 2000 tickets being sold) and that there will be incentives for individual band families who sell the most. Each student  $6^{th}$  –  $12^{th}$  grade will be sent home 3 tickets for the family to sell – please return all unsold tickets. There is a potential to make \$13,000.00 from this fundraiser. Currently 120 tickets have been sold or committed to. Suggestion was made by Mr. Frankenfield to add additional cash prizes for  $2^{nd}$  and  $3^{rd}$  place drawing. We will consider this for next school year.

Hospitality Table – Debbie Wurzelbacher reported that Aug. 24 (Seniors), Sept. 7 (Juniors), Sept. 21 (Sophomores), Oct. 5 (Homecoming), & Oct. 12 (Freshman).

Booster Website / Facebook – Debbie Wurzelbacher reported 755 visits to the website in July, and 337 "Likes" on facebook. She thanked Gary Baldwin, Ginny Walker, & Mary Ann Henninger for sharing pics. Ms. Mills asked about creating a FB event for the alumni night @ homecoming.

Newsletter – Debbie Wurzelbacher asked for a try-out date for RMS color guard. Ms. Mills said the week of Sept. 4<sup>th</sup> – more details to come.

Show T-Shirts – Tammy Grenier stated that today was the last day to order shirts. The shirts will be ready for delivery on Aug. 25

Spirit Wear – Lucas Stapleton will be heading it up this year. Soon he will have samples posted on the website.

## **New Business:**

Band Camp Chaperone Fees of \$125 per person with 7 parents = \$875 – this needs to be reimbursed to Mr. Roemer. Motion to pay \$194.00 to Ms. Mills made by Melanie Schmitt seconded by Tammy Grenier – motion passed. As discussed in the spring, but never voted on, Ms. Mills & Mr. Roemer needs \$1000.00 start up. Subtracting the previous motions passed of \$561.85. A motion to pay them \$438.15 was made by Melanie Schmitt seconded by Tammy Grenier – motion passed.

Mr. Frankenfield submitted a fundraiser idea for an outdoor music event that possibly the band and the choir could work together on. Good idea, but will need to discuss it further do to the costs of putting on such an event.

Mr. Steelman asked for money to purchase a book of stamps, and Mr. Frankenfield offered to donate them – thank you Mr. Frankenfield.

Concert Program Chairperson – Mr. Roemer mentioned the former band member, Neil Roesch, has offered to do the programs.
