A motion was made to waive the treasurer's report by Julie Baldwin and seconded by Carrie Smith - motion passed.

Directors' Report

Mr. Roemer thanked all the chaperones who went on the trip to Disney. He reported that all of the students were good and there were no problems. If you would like to add Disney pictures to the travel company's website, please pick up a post card with instructions – the travel company will make a cd of all the pictures for the kids. The pep band has been asked to perform this Friday at a fundraiser basketball game between the Harlem Wizards and the Ross Township Police Department and some Ross teachers. Pep band should meet @ 6pm. May 3 is the due date for the camp deposit and paperwork. May 8th the RHS band will perform @ Elda at 3pm and on May 10th they will perform for the RMS bands at noon. He would like to encourage more parent involvement with the band program, he asked about requested that each parent sign-up for 1 or 2 areas of service/fundraisers to help boost the band program. Ideas were discussed about how to increase profits with the fudge sale and membership drive. He also reported that pre camp will take place July 23 – 26th from 9-noon each day. The Band Booster open house and Parent Band Camp meeting will take place on Monday, July 22nd with the open house beginning at 5:30pm, and the camp meeting will begin at 6pm, he would like to see a strong turn-out of parents to the meeting.
