Del Pacifico at Esterillos was granted permits for an 18-Hole Billy Casper Golf Course, which is set to break ground in early 2008. The course will feature 120 golf course condos by Costa Rican architect Ronald Zurcher, who is known for the Four Seasons in Costa Rica, and a \$90 million condo project in addition to the 65 condos and homes that have already been sold.

Barry Strudwick, co-founder of Del Pacifico at Esterillos in Esterillos Este, Costa Rica, has announced it has been granted the permits to start construction of an 18-Hole Billy Casper designed golf course in early 2008. To date we have sold over 65 condos and homes, this new condo project alone will be a \$90 million venture. The Golf Club is a private and exclusive club for Del Pacifico residents and guests for other communities participating through the Master Alliance Program. The clubhouse also includes a fitness center and restaurant.
