Alumni Association/Chapter Update

Dear Fellow DKE/DKS Brothers, Parents and Friends:

The active chapter currently has 33 members and 13 pledges, and according to my math that represents 46 members assuming everyone makes it in. With only 6 members graduating, should result in 40 members at the start of the next year! It has been sometime since the chapter has been this size and congratulations are in order to all the leadership team. If anyone actually read the strategic plan we made up several years ago, we stated that for the fraternity to remain vibrant and financially sound, the fraternity needs to maintain an active membership of 40 to 50 brothers. "Those were the days my friend, we thought they'd never end.....". The DEEK house on Main St., off campus fraternities, Ed Thornley's hearse, Meredith's Diner, The Guzzle Cup, the War Memorial Gym, Davidson's Charwood Shop, I could go on and on!

1960/61 was a great year to be a DKS brother. We had the best of both worlds...no wars and a free reign to operate the fraternity under our own rules (good & bad!). The house was on Main St. was an old 3 story brick "mansion" (now the site of a McDonalds), with a great basement for parties. The place was heated by coal and the furnace required stoking on a regular schedule in winter.
