



**THE SUGAR BEET COOPERATIVE MEMBER SUBSCRIPTION AGREEMENT**

The membership interest hereby subscribed for is intended to confer the right to purchase consumer goods and services at member prices and to participate in the governance of the Cooperative in accordance with its bylaws. The membership hereby will entitle the holder to no dividends or other monetary return, will be nontransferable except to the Cooperative, will be redeemable only in limited circumstances, and subject to other terms and conditions in accordance with the bylaws of The Sugar Beet Cooperative. All information obtain during the course of this membership purchase will remain confidential and will not be shared outside of the Sugar Beet Board and administrative staff without the specific permission of the holder.

The funds remitted hereby are intended to be used to secure additional financing to fund the development of The Sugar Beet Co-op. All such funds are subject to the risks inherent in any start-up enterprise of this character and may result in the loss of part or all of such funds. Persons who cannot afford to incur such losses should not subscribe to purchase memberships.

For the purpose of facilitating access to consumer goods by providing necessary funds for a proposed retail food store and community center, and to acquire a membership interest in The Sugar Beet, I hereby subscribe to purchase a membership as:
