

Chippewa Valley Blues Society Meeting April 12th, 2011

Approval Of The Minutes:

One small change will be made, Approval to spend \$500.00 on the website had been made six months ago and will be deleted from the March minutes by Mary Dettman. A motion was made to approve the minutes by Dan Callan and seconded by Dan Kebshaw all were in favor.

Treasurers Report:

Lust IV had gross receipts of \$1,888.00, expenses were \$976.24, memberships were \$170.00 and generation over gate was \$584.00 for a net profit of \$741.76, as well as \$170.00 in new and renewed memberships.

CVBS has \$4,504.75, with an outstanding bill of \$500.00, plus a bill yet to come from Grub-n-Pub.

TNB has \$5,725.91.

Dan Kebshaw made a motion to accept the report and Mike Kelly seconded it. All were in favor.

Old Business:

Dan Callan said there would be a meeting at Shari's Chippewa Club on April 18th for The Blues on the Chippewa.

Website: A vote to change the website, (using Square Space) to Chippewa Valley Blues.com, .net, .org and .co was made along with the cost of \$108.00. Mike Fischer made the motion and Faith Ulwelling seconded it, all were in favor.

Everyone agreed that the president should be the web master but is to be tabled until next month's meeting. A motion was made by Dan Callan to allow Dan Kebshaw to spend up to \$450.00 for two membership for website. Mike Kelly seconded motion and all were in favor.

New Business:

Blues Notes for Grub-n-Pub:

Mike Fischer has been doing the Blues notes for Grub-n-Pub for the past 14 months and suggestions for new material. Mike Vanderwalle agreed to help him out with this.

TNB:

Mike Fischer asked all attendees to please help to find sponsors for TNB and suggested asking your dentist owners of restaurants, etc..

Rob Edwards asked for extra monies for gas and upkeep of the Blues mobile. Mike Fischer made a motion to give \$150.00 annual sponsorship and Mike Kelly seconded, all in favor.

Dan Callan asked for \$600.00 for Blues on the Chippewa, which is a \$100.00 increase from last year. He wants the first payment made in June 1st, 2011 and second payment on August 1st, 2011. Dan Kebshaw made the motion and Mary Dettman seconded it, all were in favor.

Mike Vanderwalle asked for \$250.00 for WHYS radio. Mike Fischer made the motion to approve this and Dan Callan seconded it, all were in favor.

Mike Kelly made a motion to adjourn the meeting, Rob Edwards seconded it and all were in favor.
